

Geometric Wealth Advisors, LLC is registered with the Securities and Exchange Commission as an investment adviser. Brokerage and investment advisory services and fees differ and it is important for you to understand the differences. Free and simple tools are available to research firms and financial professionals at Investor.gov/CRS, which also provides educational materials about broker-dealers, investment advisers, and investing.

What investment services and advice can you provide me?

We offer investment advisory services to retail investors, which principally include discretionary investment management and financial planning. Our discretionary authority to buy, sell, and otherwise transact in securities in your account(s) is granted in our advisory agreement and is only limited by your reasonable restrictions or our mutual ability to terminate the advisory agreement. Our advice is not limited to certain types of investments. We do not offer proprietary products. We do not have a minimum account size or investment amount to retain or maintain our advisory services.

We also provide tax and estate planning services through our duly-licensed and qualified personnel. Tax services include tax return preparation, tax planning/consulting, quarterly voucher preparation, and tax notice assistance/representation. Estate planning services include a periodic review of a client's estate plan, estate plan organization, and asset titling and beneficiary designation confirmations. Importantly, clients should be aware that we are not a law firm and none of our personnel render any legal services, and as such clients should not construe our personnel as their legal counsel.

We monitor your accounts on an ongoing basis as part of our standard investment management services, and we perform an annual review to ensure your portfolio remains aligned with your investment plan. It is important that you keep us apprised of your financial situation so we can conduct more frequent reviews if necessary.

What fees will I pay?

You will incur fees based on a percentage of your assets under our management (which are generally 0.25% to 1.00% per annum). Fees are paid quarterly in advance, and are subject to a minimum annual fee that is subject to negotiation at our discretion. In addition, you will also generally incur fees and costs charged by third parties, such as custodian fees, account maintenance fees, and transaction charges. You will also pay product expenses such as internal expense ratios for mutual funds or ETFs. For any portion of your portfolio where we engage a sub-adviser, you will also pay a sub-adviser fee specific to those assets.

When we charge an asset-based fee, the more assets there are in your account(s), the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account(s).

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

The custodian we recommend provides us various products and services that are intended to directly benefit you, us, or both of us. These products and services are principally practice management software, duplicate client confirmations, access to an institutional trading desk, access to block trading capabilities, and access to an electronic communication network for order entry and account information. To the extent a custodian provides us products or services that don't directly benefit you, this creates an incentive to recommend that custodian.
